Update on Rangitahi Voices Waihou River clean-up

• River cleanup planned in Waihoul Valley (likely near Paeroa) with BBQ trailer support

Invasive freshwater clams update (Reporoa to Turangi) – Rachel

- Clams found in Waikato River and Aqua Park (two species: Asian and Australian).
- Education focused on preventing spread to Lake Taupō.
- Resources developed with MPI and Biosecurity NZ.
- Messaging includes "Check, Clean, Dry" and distinguishing clams from native kakahi.
- Resources available online and shared with schools and parents.
- Rachel to continue school outreach and collaboration with MPI/Biosecurity NZ.
